MINUTES OF A REGULAR MEETING OF THE MAYOR AND COUNCIL OF THE CITY OF FLORALA HELD APRIL 8, 2024 IN THE AUDITORIUM AT FLORALA MUNICIPAL COMPLEX.

Workshop was held from 6:00-6:30 PM for topics of discussion: FY2024 Budget Amendments.

The meeting was called to order at 6:30 p.m. by Mayor Robbins with the following members present:

Councilman Robbins stated that if we don't get the grants, we need to come back to vote on this sponsorship donation.
