

MINUTES OF A SPECIAL CALL MEETING OF THE MAYOR AND COUNCIL OF THE CITY OF FLORALA HELD MAY 24, 2024 AT 5:00 PM IN THE AUDITORIUM AT FLORALA MUNICIPAL COMPLEX.

The meeting was called to order at 5:00 p.m. by Mayor Robbins with the following members present:

Councilwoman Wallace-Patton, Councilwoman Inabinett, Councilwoman Franklin, Councilman Robbins, Mayor Robbins. Absent: Councilman Bryan.

The invocation was given by Mayor Robbins.

The Pledge of Allegiance was given by Mayor Robbins and all present.

The first item on the Agenda was the future plans for the Florala Family Care facility at 24245 Fifth Avenue. A copy of the lease agreement and a copy of the letter from Dr. Kraft's attorney was provided to all Council members and the Mayor. Councilman Robbins made the motion to go into Executive Session to discuss and Councilwoman Inabinett seconded the motion. Time out into Executive Session: 5:02 PM. Mayor Robbins called for the vote. **ROLL CALL VOTE:** Yeas: Councilwoman Wallace-Patton, Councilwoman Inabinett, Councilwoman Franklin, Councilman Robbins. Nays: None. Motion carried.

The second item on the Agenda was approval for Council and Mayor to return from Executive Session into Regular Session at 5:36 PM. Councilwoman Wallace-Patton made the motion to come back to Regular Session and Councilwoman Franklin seconded the motion. The third item on the Agenda was to approve a motion made by Councilman Robbins to not honor the request of the letter received from Dr. Kraft's attorney, Lee & Lasseter P.C., until there was further communication with our city attorney, Meredith Peters regarding a review of the letter and lease agreement. Councilman Robbins made this motion and Councilwoman Wallace-Patton seconded the motion. Mayor Robbins called for the vote. **ROLL CALL VOTE:** Yeas: Councilwoman Wallace-Patton, Councilwoman Inabinett, Councilwoman Franklin, Councilman Robbins. Nays: None. Motion carried.

Mayor Robbins made an announcement that the ribbon cutting for Healing Tools for Warriors would be on May 25, 2024 at 10 AM at their facility at 23568 Goldenrod Avenue.
