

MINUTES OF A SPECIAL CALL MEETING OF THE MAYOR AND COUNCIL OF THE CITY OF FLORALA HELD  
SEPTEMBER 1, 2020 AT 12:00 NOON IN THE COUNCIL CHAMBERS OF CITY HALL.

The meeting was called to order at 12:00 P.M. by Mayor Holley with the following members present:

Mayor Holley, Councilwoman Wallace-Patton, Councilwoman Robbins, Councilwoman Inabinett.

Absent: Councilman Burleson, Councilwoman Mathis.

The Invocation was given by Councilwoman Wallace-Patton.

The Pledge of Allegiance was given by all present.

First item on the Agenda was to canvass the Provisional votes and read the Canvass Resolution 20200901. The City Clerk opened the sealed Provisional box containing the Provisional votes. As per the Board of Registrars Report, there were (2) Provisional ballots. The votes were read out loud for all the Council members to tally on the tally sheet provided. The City Clerk read the report from the Board of Registrars that (2) Provisional votes did not count. Mayor Holley read the Canvass Resolution in its entirety. This Resolution shows results as such: For Mayor: Jeff Burleson Total of 189, 185 Regular, 4 Absentee; Terry Holley Total 217, 213 Regular, 4 Absentee. For Council District One: Sylvia Wallace-Patton Total 44; Charles "Chuck" Willis Total 29. For Council District Two: Jimmy Carter Total 34; Gayle C. Robbins Total 37. For Council District Four: Joseph "Bobo" Hunt Total 36; Shelia Franklin Total 45. Councilwoman Inabinett made a motion to approve Resolution 20200901 and Councilwoman Wallace-Patton seconded the motion. Mayor called for the vote. **ROLL CALL VOTE:** Yeas: Councilwoman Wallace-Patton, Councilwoman Robbins, Councilwoman Inabinett, Mayor Holley. Nays: None. Motion carried.

Next on the Agenda was to read in their entirety, the Certificate of Election for each Council Position and the Mayoral Position. Mayor Holley read the Certificates of Election for Sylvia Wallace-Patton-District One; Gayle C. Robbins-District Two; Shelia Franklin-District Four; Terry Holley-Mayor Position. Councilwoman Inabinett made a motion to approve and Councilwoman Wallace-Patton seconded the motion. Mayor called for the vote. **ROLL CALL VOTE:** Yeas: Councilwoman Wallace-Patton, Councilwoman Robbins, Councilwoman Inabinett, Mayor Holley. Nays: None. Motion carried.

Next item on Agenda was approval of proposal from Pitts Media (suggested by the ACE committee) to create advertising for the City of Florala. Councilwoman Robbins presented the information. Councilwoman Wallace-Patton made a motion to approve and Councilwoman Inabinett seconded the motion. Mayor called for the vote. **ROLL CALL VOTE:** Yeas: Councilwoman Wallace-Patton, Councilwoman Robbins, Councilwoman Inabinett, Mayor Holley. Nays: None. Motion carried.
